PUBLIC COMMENT:

Derek Campbell, 407 Jefferson – had a sewage explosion into his basement after DPW had to clean out the main sewer line because of baby wipes causing the main line to be plugged. Jetting the backup allegedly caused sewage to explode into Mr. Campbell's basement. His estimate to restore his basement will be \$6,000 his home insurance paid him \$5,000. Mr. Campbell is asking Council to give him another \$1,000 to fix his home. Council encouraged Mr. Campbell to continue to work with City Staff towards a solution.

Jonathan Poer- Introduced himself to Council as the sole candidate on the ballot seeking to be elected as Lenawee County District Judge. He claims to have been practicing law since 1978, including 36 years in the prosecutor's office and the last year as the District Court Magistrate.

County Commissioner Jim Driskill – Lenawee County Legislative Dinner will be October 29, 2014 at the LIDS Tech Center in Adrian. The speaker will be State Senator Bruce Caswell about the Department of Human Services. Bill Harke from Milk Source and Grant Baumann from Region 2 Planning will be having presentations. Michigan State Tax Commission had audits on the local assessors and eight units had major violations but there were some with no violations.

Lenawee Now- Jim Van Doren, Tim Robinson- Showed an audiovisual presentation of the Lenawee County area, emphasizing the contributions made recently by Lenawee Now towards the economic development and prosperity of the County. A number of these contributions may have had a positive effect on the western part of Lenawee County, including the City of Hudson.

The Planning Commission voted on Monday, September 22, 2014 to recommend that Council approve a request from Bryan High of 119 N Maple Grove Ave. for a variance (under Section 15-34 Curb Cut Requirements of the City Code) to widen his driveway approach by 14 feet to accommodate a camping trailer.

During the meeting no objections were received, nor have any written objections been received to the variance. The request is being submitted to the City Council, acting as the Zoning Board of Appeals. Attached for Council's review is a copy of the Variance Request as well as the relevant Zoning Ordinance and supporting documents.

Article 4, Division 2, Section 2-131 of the Code of Ordinances requires the sale to be done through competitive bidding authorized by at least 4 members of Council.

APPROVE: Financial Audit Report for Period ending June 30, 2014

Philip Rubley, City Auditor, has prepared the financial statement of accounts for the period of July 1, 2013 to June 30, 2014. The auditor reviewed his opinion with the Council and give an unqualified audit which is the highest standard given by auditors.

Mr. Rubley provided copies of the audit and during his presentation he told council that the accounting practices at the City Offices are excellent. He stated that there has been a major improvement in the overall position of the City. The Fund Balance has increased by approximately \$81,000. He felt that the governmental funds are in really good shape.

APPROVE: Show Cause Hearing – Article III Dangerous Structures – 105 Lincoln St

Section 5-56 of the City Code (attached) governs the procedures for dealing with properties deemed by the City building inspector to be dangerous buildings. On July 11, 2014, Ray Taylor, the City building inspector, has deemed 105 Lincoln Street to be a dangerous structure.

Per City Code, the next step is for Council to hold a hearing to hear facts and officially determine whether the building in question is unsafe, and if so, to issue an order requiring the owner to repair or demolish the building within 10 days. If the owner fails to comply, the City then has the authority to refer the matter to the City Attorney to have the building demolished and the costs assessed as a lien on the property.

When this agenda item was first addressed at the September 2nd Council Meeting, Council voted to postpone this hearing until October 7th to allow the owner to remove any personal belongings and to give the Council a date for demolition. Nothing appears to have been done at the property since September 2nd.

CITY MANAGER'S REPORT:

- The Governor will be visiting the Southern Michigan Center for Science and Industry on October 16th. Council members are expected to be invited to this event.
- Promedica has purchased the former United Bank & Trust building downtown. They intend to move Thorn to the location. All existing services will remain available at the new location, including lab and X-ray. Old National Bank will continue to operate the drive-through and have inside service; the downstairs will be preserved and will remain available for use by the community. Promedica will be coming to a future Council meeting to provide additional details and answer questions.
- We received notification that our application for this year's Tree Grant has been approved. We are to receive the full requested amount of \$2,000. The 20 trees have been planted, and we should expect to receive the check around the end of the year.
- The currently-estimated date for the start of demolition of the Tiger's Den is within the next two weeks, with completion still expected by the end of this month.
- The Engle Trail project is on schedule, with paving tentatively scheduled for October 15-16, which should allow the Sunrise meadows repaving project to be completed this year. City Manager has been in contact with the Michigan Greenways and Trail Alliance, and the Hudson Trail System will be included on next year's map of Statewide Trails.
- The Police Department's new SUV Patrol vehicle has been received, outfitted, and placed in service.
- The demolition of the former Homer Donaldson building at Mackenzie and School Streets is nearing completion. Alpine Manufacturing purchased the site and intends to expand there.
- A reminder that from Feb 7 March 29 next year, "The Way We Worked" Smithsonian Museum travelling exhibit will be in Hudson. Ray Lennard is chairing the committee running the exhibit, which will be promoted in Michigan and Ohio.
